

By participating in the We Save program, you can save energy and earn a rebate when you retrofit an existing furnace with a new, high efficiency electronically commutated fan motor (ECM).

What rebate can I earn?

New Retrofit ECM added to Existing Furnace = \$50

What is an ECM?

An ECM is a high efficiency brushless permanent magnet motor that is electronically controlled to operate over a broad range of speeds, encompassing both constant torque and constant airflow designs.

In addition to using less energy than conventional PSC (permanent split capacitor) motors, ECMs are quieter and maintain more consistent indoor temperatures.

How Do I Qualify?

- Residential customers receiving electric service from the City of North St. Paul are eligible for a rebate when they retrofit an existing furnace with a new ECM.
- **Rebate is for retrofit of existing furnace only. This rebate does not apply to new furnaces with factory installed ECMs.**
- Information on rebate application must match invoice.
- Customer must apply for rebate within one year of the purchase date shown on the sales receipt.
- Copy of dated invoice showing ECM was installed and manufacturer and model number of ECM is required.
- Incomplete rebate applications will not be processed.
- Rebates are limited to one rebate per customer account per year.
- Rebate requests are processed on a first-come first-serve basis. Annual rebate funds are limited. Rebate programs, qualifications, and amounts are subject to change at any time.
- Qualifying customers must apply for rebate by November 30, 2020.
